AN APPROPRIATION ORDINANCE TO BE ENTITLED: AN APPROPRIATION ORDINANCE AMENDING AND SUPPLEMENTING THE ANNUAL OPERATING BUDGET FOR THE FEDERAL GRANTS FUND FOR COLUMBIA COUNTY FOR THE YEAR 2018. AN APPROPRIATION ORDINANCE INCREASING ANTICIPATED REVENUE FOR FEDERAL GRANTS FUND FROM GRANT AWARD.

WHEREAS, Columbia County applied for and was awarded a grant through the State of Arkansas for an Arkansas Community & Economic Development Grant the sum of \$111,467.00; and

WHEREAS, and Agreement has been entered into by the Arkansas Department of Economic Development and Columbia County for the rehabilitation of an existing water storage tank in the Free Hope community; and

WHEREAS, we are hereby increasing anticipated revenue for the Federal Grants Fund by \$111,467.00 and appropriating 100% to 3502.0423.3009/other professional services; and

WHEREAS, no budget was prepared for the 2018 Federal Grants Fund, therefore we are hereby creating this Federal Grants Fund Budget.
